- Completion of all forms and necessary documents prior to Monday, April 14th 3PM
- Bidder registrations will not be completed after Monday, April 14th 3PM
- Documents required for pre-registration
 - Valid, legible copy of driver's license (front & back) Must match registered bidder information
 - Valid automobile insurance (for vehicle registration purposes). Must match registered bidder information. Bring physical card. We cannot accept a virtual image on your phone.
 - Completed forms from link (Public Terms & Conditions, W-9, Public Buyer Agreement)
- Registered public buyers attending the auction are required to provide a refundable \$200 money order deposit. No cash will be accepted for the registration. Bid numbers will be assigned upon receipt of this deposit. If no purchase(s) are made, Manheim Keystone Pennsylvania will mail deposit check directly to the buyer address provided at registration, the week following the auction.
- To secure your bidder badge from online registration, show driver's license and provide \$200 money order during preview days or auction morning onsite at Manheim Keystone facility 10am.

Buyer Guidelines

- Registered bidders only permitted on site. No guests.
- Jump boxes permitted on site.
- Registered AuctionACCESS dealers can bid on site or via simulcast.
- Maintain social distancing when bidding.

Terms and Conditions

Thank you for attending Manheim. In these Terms and Conditions ("Terms"), "Auction," "we," "us," and "our" refer to Manheim and its affiliates, and "you" and "your" refer to you as a customer at our auctions. By attending our auctions as a bidder or using any of our services, you agree to abide by the Terms detailed below, as amended from time to time:

- We are merely the auctioneer and not a party to any transaction between vehicle buyers and sellers. We are not the seller or transferor of any vehicle you purchase at auction, nor the buyer or transferor of any car you sell. 1.
- We may amend these Terms from time to time by posting updates online at Manheim.com and will revise the effective date when we do so. You agree that 2. the most current version of these Terms will apply to your business with us

Any fees, including buyer's fees, late fees, renege fees, membership fees, title fees, and storage fees can be found on the current fee schedule applicable to the relevant Auction location and available in our office. We may change any of these fees, prior to a given sale, without

Warranties, Title, and Risk of Loss

All vehicles sold under these Terms are used or salvage vehicles and are sold without any warranty as to condition. IN PURCHASING A VEHICLE AT AUCTION, YOU AGREE THAT THE VEHICLE IS SOLD AS IS, WHERE IS, AND HOW IS. AUCTION DISCLAIMS ANY AND ALL WARRANTIES, REPRESENTATIONS, OR GUARANTEES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Any information about vehicles available at Auction, including information about the make, model, year, odometer reading, or damage, is provided for informational purposes only. It is your responsibility to verify any information provided or announcements made about any vehicle you wish to purchase or

sell. You should assume that any vehicle sold at Auction has some material damage, including frame or structural damage.

If not provided on sale day, the title for any vehicle you purchase will be mailed by regular ground mail, within the timeframe allowed by local Auction policies, to the mailing address you provided above, after you have paid the purchase price and any fees in full. We reserve the right to withhold title to any vehicle you have purchased if you have not paid for all vehicle purchases in full.

Like all auto auctions, our various facilities are busy places with many vehicles, customers, and personnel moving around the premises at all times, particularly during sales events. You enter the Auction premises at your own risk. While on Auction premises, you agree to use extreme care to avoid injury to yourself and others, both in moving vehicles on and off the premises and in traversing any sale lanes, parking lots, and offices on foot and otherwise. We are not liable for bodily injury or property damage you encounter on the Auction premises or by using our services. You hereby waive and release your right to recover from Auction, its directors, officers, employees, representatives, and agents any and all damages, losses, liabilities, costs, or expenses whatsoever, whether direct or indirect, known or unknown, forescen or unforescen, which may arise from or be related to bedily injury or property damage that occurs on Auction premises or from using Auction's Services.

Auction is not responsible for damage to, acts of vandalism to, or theft of items from vehicles or other merchandisc before, during, or after an auction. You

are responsible for transporting any vehicles you purchase off Auction's premises.

Vehicle and Transaction Disputes
